CHAPTER 12

Chapter 3 – Charter Club Executive Board (CCEB), Section 3.0 of the Charter Club Policies and Procedures, Restated and Approved by the Board of Directors on March 9, 2023 directs that “The CC shall identify specific officers, including duties in Section 12.0 of the CC P&Ps...” Those specifics are as follows:

3.0 Charter Club Executive Board:

The following sections modify Section 3.1 of the CC P&P:

3.1.1 Officers: The officers of the Charter Club Executive Board (CCEB) shall be a President, Vice President, Secretary and Treasurer. The duties of the CCEB officers shall be as set forth in Section 3.3 of the Sun City Grand Community Association Chartered Club Policies and Procedures, Restated and Approved by the Board of Directors on March 9, 2023.

3.1.2 Members-at-Large: the CCEB shall have 3 Members-at-Large elected by a membership vote. Duties include, but are not limited to:

- Representing the membership at general Board meetings.
- Performing other duties as assigned by the President.

3.5.1 Election and Terms of Office: The GPC shall maintain a two-year term for all members of the CCEB. The positions of President, Treasurer and one Member-at-Large shall be elected for terms beginning in even numbered years (e.g., 2024, 2026, etc.). The positions of Vice President, Secretary and two Members-at-Large shall be elected for terms beginning in odd numbered years (e.g., 2023, 2025, etc.).

Chapter 6 – Club Activity Supervision, Rules and Safety. The following section adds to Chapter 6.0 of the Charter Club Policies and Procedures Restated and Approved by the Board of Directors on March 9, 2023:


6.7 Member Requirements: GPC requires all members to monitor once each calendar year. The CCEB will, from time to time, determine those activities that qualify for a monitoring credit (e.g., monitoring, court cleaning, volunteering, player training, AED training). The CCEB will establish, from time to time, the penalties a GPC member may incur for failing to monitor (e.g., higher club dues). Monitors are allowed to play while they are monitoring drop-in during the summer season (e.g., April through September) only.

CHAPTER 13

- 1.0 Club Member Name Badges: Club members are required to wear the proper GPC approved name badge with the correct year sticker while on the courts.
- 2.0 Court Shoes: All members and Guests must wear proper non-marking court shoes.
- 3.0 Ball type: Except as otherwise approved by the CCEB, players, regardless of whether a club member or resident, will use the ball provided by the club.
- 4.0 Approved paddle list: All club members and their guests will use only paddles approved by the club, found on the grand pickleball website.
- 5.0 The CCEB will, from time to time, establish types, rules and times of GPC Activities. Such Activities may include, but are not limited to, Drop-In, Ladders, and Training Events. The CCEB will assess such factors as season of play (e.g., high season October-March and summer season April-September), skill levels of play, demand for reserving courts, number of new members joining, activities that encourage broad usage by most members, as well as such other factors the CCEB deems appropriate to achieve the greatest usage for the greatest number of GPC members.
- 6.0 Mixers, tournaments and inter-community play must be approved by a membership vote.
