# Treasurer Report:

Mike McDonald presented the Club Financial Statement for December 2017:

## **President's Report:**

Troy Konz read a thank you letter from a member's wife on behalf of her husband who recently passed away. It was proposed that the Club make a \$100.00 donation to a Charity on behalf of the member. John Olson informed the membership that he believes the Charter Club Rules prohibit the Club using member dues for charitable donations. It was later verified by John Olson that Section 2.6 of the Chartered Club

rules state that "dues shall not be used for monetary contributions to charitable organizations".

# **Soldiers Best Friend Fund Raiser (SBF)**

Troy Introduced representatives from SBF to receive the \$4843.00 check from the "Play with a Pro" Fundraiser that took place on December 17, 2018.

 Roy Cirincione, Angel Malendano and SBF dog Louie, presented the Club with a signed memorial plaque from SBF, thanking us for our generous contribution to their charity. The Club presented SBF with a check representing the amount donated and pictures were taken of them with Club members attending the meeting.

### **New Business:**

Troy presented Seymour Rifkind from "International Pickleball Teaching Professional Association" (IPTPA)

- The IPTPA has developed a skill based rating system and a corresponding training program for beginning instructors. It was proposed that the Club send two Club members to their eight-hour course with a ITPTA master teaching professional.
- The cost to send three (3) Club members to the ITPTA certification class is \$600.00. The next dates for training will be in Buckeye, AZ on January 27<sup>th</sup> & 28<sup>th</sup>. The cost to maintain the Level 1 certification once it is obtained is \$120.00 annually. Members suggested to attend were Marlene Berwald and Victor Moreno. A 3<sup>rd</sup> member will be identified.
- Membership for the Club in ITPTA is \$150.00 for 3 years
- Linda Hoggatt made a motion to approve the training and the motion was approved (adopted) by the membership. (With the stipulation that the copyright rules for using the material extend to the entire Club and not just to one individual. If the copyright does not extend to the Club, the training should not take place).

## **Court Maintenance Equipment**

Troy recommended that the club purchase vacuums and/or wet vacuums to supplement the monthly Court Maintenance by CAM.

• Cost approximately \$2500.00. A Court Maintenance team comprised of Club members is being established and headed by Craig Soubliere. A sign-up sheet is on the wall for this team.

 Keith Darrow moved that the cleaning equipment be purchased and the motion was approved (adopted) by the membership. The equipment will be purchased with CAM's approval regarding the court resurface warranty and any possible liability issues with our members performing court maintenance.

#### **Electric Ball Machines**

Troy recommended purchasing two (2) new electric ball machines. The battery - operated machines charge does not last long and they are experiencing some issues.

• Keith Darrow made a motion to purchase the electric ball machines and the motion was approved (adopted) by the membership.

## **Water Bottle Fillers**

- Troy will ask Ken Olson for CAM's approval to install water fountains with bottle
  fillers and installation of an ice machine in the Pavilion. If approved by CAM,
  Troy recommended the Club purchase two water fountains with bottle fillers as
  well as an ice machine. Estimated cost for the water bottle fillers are not to
  exceed \$1000.00 each and an ice machine.
- Linda Durkee made a motion to purchase two (2) water fountains with bottle fillers and an ice machine and the motion was approved (adopted) by the membership, only after checking with CAM if they are allowed.

Spring Training Game – The Texas Rangers vs the Seattle Mariners – March 4<sup>th</sup>, Gates open at 11:00 am and game starts 1:05pm in the Party Tent Section.

- Marlene Berwald will coordinate the purchase of tickets for the game for Club members. The cost is \$30.00 per person and the Club is not expected to incur any net cost. Meal is included in the ticket price.
- Jeff Cretors made a motion to purchase 100 tickets at a cost of \$3000.00 and the motion was approved (adopted) by the membership.
