**Court Level Designation** David Nedelman presented committees recommendation to add zone designation signage to Morning drop in times. Trial period through end of April will designate the following zones of play:

RED SIGNS	6 courts 17-22	4.0-5.0
BLUE SIGNS	8 courts 9 -16	3.5-4.0
RED SIGNS	8 courts 1-8	2.0-3.0

It is encouraged that you select your zone based on your skill level. It is intended to promote play and make it easier for newer members to chose a court. Email from Troy will advise members of start of trial. Discussion presented many views of recommendation. Theme will be KNOW YOUR ZONE AND CHECK YOUR ZONE. Show of hand vote indicated 80% in favor of trial period. It is just a recommendation, and all courts should be used during dropin.

#### **NEW BUSINESS**

**Ice Machine Update** Request is still working its way through the pipeline. Scheduled to come before Board of Directors during the March timeframe.

**Skill Assessment** Linda Hoggatt and team will begin skill assessments for those players needing to know their level. It will take about 1 hour. Informations regarding registering for sessions will be forthcoming.

**Charter Club By Laws** It has been determined that club is out of compliance with previous by laws. Work is beginning on new methods for chapter 12 and 13 per CAM regulations. Some topics to be included are code of conduct, and staggered tenure of board members.

**Pick Olympics** Back by popular demand, event will be held on Wednesday, April 3<sup>rd</sup>. This is a series of skills to be completed in each skill level. More information to be posted later

**POP up Events** Rob and Jane White will continue to conduct smaller skill level events. So far 2 skill levels successfully completed. Womens, mens and mixed levels will be included going forward.

**Skill Level Drop ins** Guidelines for attending skill level clinics will be sent to all members. Players should only attend drop in for their designated skill level. Jeanne Harteau reminded club that these drop ins were added to club to alleviate crowded courts during 9 to 12 am drop in. Basic Guidelines will be

1. If player is in ladder, plays that drop in level
2. Player gets evaluated at monthly evaluation sessions
3. Player has USAPA rating in skill level

**CAM Card Swiping** It is a club rule to swipe card each time you enter courts to play. In January there were 1422 swipes. Troy has asked there to be a focus on swiping so that we can determine true court usage. Discussion held about “bending” your cam card to the left in the card reader adjacent to the new courts. Mike O’Meara, technical adviser, shared that CAM Card is our only tool, and that the card readers were purchased to allow players to record their attendance. Troy and Mike encouraged all members to report to them any card swiping issues.

**Work Orders** Requests have made regarding trees to be trimmed around the courts.

**Locked Gates** Troy has been working with CAM and the city of Surprise regarding the locked gates on courts 19, 20 and 21. Pickleball Club has asked to remove locks to ensure ease of exiting the courts in an emergency.

**SPIN CYCLE FEBRUARY**

1. Should eyewear be required for additional safety at the courts?
2. Proper footwear, meaning court shoes, should be worn at all times
3. Large planters in breezeway are in the way, can we get them relocated
4. Can we do the “spin cycle” at the beginning of the meeting?
