The Board of Directors is happy to announce the addition of a new Board-Appointed Advisory Committee, the Lifestyles Advisory Committee (LAC); their charter was approved at the August 13, 2015 Board of Directors' meeting.

Duties and Responsibilities are as follows:

- > When requested:
  - 1. Review issues relevant to Chartered Clubs and Interest Groups
  - 2. Collaborate with the Activities and Fitness Managers and/or General Manager with any lifestyle issues and/or any changes to lifestyle policies.
  - 3. Consider new or changes in existing amenities that would enhance the lifestyle of current residents and attract future residents to the community.
  - 4. Consider new amenities and programs that will enhance the quality of life of our residents who are planning to age in place.
  - 5. Consider lifestyle issues brought to the committee by residents.
  - 6. Make recommendations to the Board, as appropriate.
  - 7. Provide a representative to the monthly Chartered Club Presidents' meeting.
  - 8. Perform tasks requested by the Board of Directors.

There are six open positions on the new Lifestyles Advisory Committee. The six appointed members will serve staggered terms. The initial appointments will be for three members to serve 8 months with their term ending on June 30, 2016 and three members to serve one year and 8 months with their terms ending on June 30, 2017. Thereafter, terms will be for 2 years. A "Special Call for Candidates" is being conducted to fill these positions.
